# **SECTION 5: Firefighting measures**

### 5.2 Special hazards arising from the substance or mixture

Hazards from the substance or mixture : Flammable liquid and vapour. In a fire or if heated, a pressure increase will occur and the container may burst, with the risk of a subsequent explosion. #### 7.1 Precautions for safe handling

#### **Protective measures**
